Pursuant to the requirements of the Regulation 30 of the Listing Regulations, as amended, from time to time, we hereby inform you that a fire accident occurred at one of our Contract Manufacturing Unit i.e., Dadiji Snacks Private Limited ("DSPL") situated at Plot No. – 1070, 1070/2116 and 1088, Arai Main Road, Near Singariyawan, Daniawan, Patna, Bihar, India – 801304 today i.e., **Sunday, August 17, 2025**. The Fire was controlled within time and no casualty or injury to life have been reported.

Further, we hereby inform you that the DSPL has adequate insurance coverage and have informed the Insurance Company about the incident. The DSPL is in process of ascertaining the actual loss caused due to the fire.

The Company will have minimal business loss due to the incident, and until operations at DSPL fully resumed, the requisite demand will be catered from other nearby located manufacturing unit.

The Company will update the stock exchanges of material development, if any, in the aforesaid matter in future.
