DEED OF ADHERENCE III

THIS DEED OF ADHERENCE III (“Deed”) is made on June 01, 2021 by:

AND

IIFL SPECIAL OPPORTUNITIES FUND – SERIES 7, with Permanent Account Number AABTI5211L, represented by its Investment Manager - IIFL ASSET MANAGEMENT LIMITED, a company organized and existing in accordance with the laws of India, with its registered office at IIFL Centre, Kamala City, Senapati Bapat Marg, Lower Parel, Mumbai – 400 013 (the “**Investor2G**”);

AND

INTENSIVE SOFTSHARE PRIVATE LIMITED, a company duly organized and existing in accordance with the laws of India, with its registered office at 914, Raheja Chambers, 9th Floor, Free Press Journal Marg, Nariman Point, Mumbai-400021 (the “**Other Shareholder**”);

AND

THE PERSONS LISTED IN SCHEDULE II (collectively as the “**Promoter Family Members**” and individually as a “**Promoter Family Member**”);

AND

BIKAJI FOODS INTERNATIONAL LIMITED, a company incorporated under the laws of India with company registration number U15499RJ1995PLC010856 and having its registered office at F 196 -199, F 178 & E 188, Bichhwal Industrial Area, Bikaner, Rajasthan – 334006 (the “**Company**”).

Investor2A, Investor2B, Investor2C, Investor2D, Investor2E, Investor2F and Investor2G are together referred to as “**Investor2**”. The Promoter Family Members, Investor1, Investor2, Other Shareholder, Investor3A, Investor4, the New Shareholders and the Company shall individually be referred to as a “**Party**” and collectively as the “**Parties**”.

RECITALS:

- (A) The New Shareholders have purchased total 48,170 (Forty-Eight Thousand One Hundred and Seventy) Equity Shares of the Company from Shri Deepak Agarwal, a Promoter Family Member.
- (B) This Deed is entered into by the New Shareholders in compliance with i) the Share Subscription, Share Purchase and Shareholders’ Agreement dated May 7, 2018 made between the Promoter Family Members, Investor1, Investor1 Parent, Investor2, Other Shareholder and the Company; ii) the Deed of Adherence dated May 23, 2019 (“Deed of Adherence I”) executed between Investor1, Investor1 Parent, Investor2, Investor3, Other Shareholder, the Promoters Family Members and the Company; and iii) the Deed of Adherence dated October 01, 2019 (“Deed of Adherence II”) executed between Investor1, Investor1 Parent, Investor2, Investor3, Investor4, Other Shareholder, the Promoters Family Members and the Company (all collectively referred the “**Agreement**”).

THIS DEED WITNESSES as follows:

- 1. The New Shareholders confirm that they have been supplied with a copy of the Agreement and have fully understood the terms thereof.
- 2. The New Shareholders hereby agrees that:
 - (a) Notwithstanding anything contained in the Agreement to the contrary, the New Shareholders are not entitled to any rights and benefits granted to, or subject to any of the obligations of, Investor1 and/or Investor2 and/or Investor3 and/or Investor4 and/or Other Shareholder (to the extent applicable to each such Investor) under Clauses 2 to 9, 10.3, 10.5, 11.1 to 11.4, 12, 13.1, 13.2, 13.3, 13.4 (b), 13.5, 14, 15, 16 (other than Clauses 16.1(d), 16.5, 16.8 and 16.11) and Clause 17 of the Agreement.
 - (b) It shall have the rights of an Investor, and be subject to the obligations of an Investor, in each case with respect to the following clauses in the Agreement:
 - (i) Clauses 10.1 to 10.4, 13.4 (a), 13.6, 16.1(d), 16.5, 16.8, 16.11, 18, 19, 20, 21 and 22; and
 - (ii) For the New Shareholders, Clause 11.5 to be read as follows: Each New Shareholder shall have the right to Transfer Securities held by it to a maximum of 1 (one) Person only and such Person shall not be Competitor. Without prejudice to the Promoters’ right under Clause 13.6, each New Shareholder undertakes that any Transfer of Securities by a New Shareholder shall require written consent from the Promoters and accordingly each New Shareholder agrees to intimate the Promoters by notice in writing about such Transfer of Securities and such notice shall include the identity of the proposed transferee, number of Securities to be sold, total

consideration for Transfer of Securities, payment mechanism and other conditions of sale. The New Shareholder agrees to conclude such Transfer of Securities within 30 (thirty) days of receipt of the Promoters written consent and undertake that such Transfer of Securities shall be concluded exactly on the same terms and conditions as intimated to the Promoters while seeking their consent and subject to the execution of a Deed of Adherence by the transferee of such Securities.

- (c) Each New Shareholder shall be entitled to exercise the rights, and shall be bound by the obligations contained in the aforementioned clauses, independently of other Investors and/or other New Shareholders.
 - (d) In the event of any conflict between the terms contained in (i) the Agreement and (ii) this Deed, then, with respect to the New Shareholders, the provisions contained in this Deed shall prevail.
- 3. The New Shareholders agree to hold the Shares transferred to it subject to the Agreement, this Deed, and the memorandum of association and Articles. However, notwithstanding anything to the contrary in the Agreement, neither amendment/changes in the Agreement nor execution of any Deed of Adherence henceforth (excluding Deed of Adherence where the New Shareholder is the Transferor) shall require the New Shareholders to be either a party to these documents or requiring them to sign these documents.
- 4. This Deed is made for the benefit of the Parties to the Agreement and every other person who, after the date of the Agreement (and whether before or after the execution of this deed) assumes any rights or obligations under the Agreement or adheres to it.
- 5. The address of the New Shareholders for the purposes of Clause 19 (Notices) of the Agreement including email id for the purpose of delivering notices and other shareholders communication, in electronic form, under the Act or Agreement are given in Schedule I.
- 6. The provisions of Clauses 1, 18, 19, 20, 21 and 22 of the Agreement shall apply mutatis mutandis to this Deed.
- 7. Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Agreement.
- 8. The shareholding pattern of the Company on a Fully Diluted Basis before and as on the date of this Deed shall be as set out under Schedule III (A) and (B) to this Deed.
